The Basics

Career Based Intervention (CBI)

- Serves students in grades 7–12
- Flexible program: can be run as an elective or as part of homeroom or interverntion period. Can utilize teacher of record
- CBI courses must be correctly coded in EMIS for state funding and compliance (252525)
- Students need a full year worth of education for at least 120 hours
- Curriculum can consist of a variety of topics

Career-Based Intervention (CBI) helps students who face academic, attendance, behavioral, or economic challenges that may affect their success in school or future careers. It provides personalized instruction focused on building confidence, motivation, and responsibility. Students explore different career options while learning essential employability skills like teamwork, communication, and problem-solving. Through work-based learning experiences such as job shadowing or internships, students connect classroom lessons to real-world opportunities. You can learn more at the Ohio CTE website.


Required Checklist



Funding

Ohio CBI programs receive funding through state CTE allocations. Schools earn this funding when their CBI courses are correctly coded and taught by certified CBI teachers, ensuring the program meets Ohio Department of Education standards for career readiness and work-based learning. Getting Started









Step 1

Schools often choose to start a CBI program after identifying student needs and staff interest. With support from your Accel CTE team we can design an innovative, long-lasting program.

Step 2

During this phase schools outline the program's goals to align with Ohio's CBI standards. This stage includes selecting a teacher, developing a curriculum, and building partnerships

Step 3

The compliance phase ensures the program meets all state requirements for funding. This includes verifying course coding, teacher of record, and accurate reporting

Step 4

The implementation phase focuses on putting the CBI program into action by enrolling students, delivering instruction, and coordinating work-based learning experiences.

Course Set Up

CBI offers flexible implementation options to fit each school's schedule and student needs. It can operate as its own elective course or be integrated into homeroom or **intervention periods** to provide career readiness instruction and support.

Full Semester Required



CBI students must be enrolled in both **Semester A and Semester B** to complete the full-year program. Each student is required to receive a minimum of 120 hours and up to 240 hours of instruction and work-based learning throughout the year to meet state requirements.

Coding Your Course



It's important to code the CBI course correctly as 252525 in the district's EMIS or Student Information System (SIS) so the state recognizes it as an approved Career-Based Intervention program. Accurate coding ensures the course is eligible for CTE funding, proper accountability reporting, and compliance with Ohio Department of Education requirements.



Teacher Requirements

CBI teachers must hold a valid Ohio teaching license along with the Career-Based Intervention endorsement issued by the Ohio Department of Education. This certification ensures teachers are qualified to deliver career readiness instruction, coordinate workbased learning, and support students facing barriers to academic and career success. **Accel offers two options for schools that do not have a CBI certified teacher.**

Fellows Program

The CBI Fellows Program funded by Accel helps cover costs for teachers to complete the CBI endorsement through the University of Toledo.

- Online graduate program through the University of Toledo for the Ohio CBI endorsement.
- Flexible online format to complete the three course, 9 credit hour program.
- Focuses on career readiness, work-based learning, and student support.

Teacher of Record

Accel can provide a certified CBI teacher to serve as the official teacher of record for your program. This allows your current teacher to deliver daily instruction without having to already be certified.

- Allows schools to offer CBI immediately without waiting for a staff member to complete certification.
- Provides ongoing guidance and support from an experienced CBI-certified teacher to strengthen program quality and implementation.



CBI Endorsement

To earn a Career-Based Intervention (CBI) Endorsement in Ohio, a teacher must hold a current Ohio teaching license, complete approved CBI coursework through a university, and have both classroom and work experience outside education.

Compliance

Career-Based Intervention (CBI) is an Ohio-approved Career-Technical Education program for grades 7–12 that helps students facing academic or economic barriers develop employability skills through classroom instruction and supervised work-based learning. <u>Learn more at the Ohio CTE website.</u>



- **Teacher licensure**: Staff must hold (or be completing) the CBI Endorsement on a valid Ohio teaching license.
 - Minimums: bachelor's degree, 2 years successful teaching, and 1 year of full-time work experience outside education.
 - School can also utilize a Teacher of Record
- Required course & EMIS coding: Every CBI student must be scheduled into the CBI Related Instruction "anchor" course (EMIS subject code 252525)
- Minimum instructional time: ODE's CBI guidance ties all CBI students to the anchor (related instruction) course each year; districts commonly schedule a minimum of 120 instructional hours.
- Work-Based Learning (WBL): CBI students can accumulate WBL hours (job placement, internship, school-based enterprise, entrepreneurship, simulated work)
 - For Ohio graduation competency, 250 cumulative WBL hours in high school is a recognized option
- Student identification & documentation: Keep evidence that participants meet CBI criteria (academic/economic disadvantage and/or disability/other barriers), plus a student portfolio displaying CBI work.

On Going Meetings Required

Schools will participate in ongoing meetings with their Accel CTE team member to ensure full compliance with Ohio CBI requirements, EMIS reporting, and program standards. These regular check-ins will help the school review course coding, licensure, documentation, and work-based learning procedures.

Work Based Learning



Discovery & Planning

CBI coordinators collaborate with local employers, workforce partners, and community organizations to identify safe, meaningful partnerships that align with student career interests and program goals.



Documentation

Schools maintain detailed records of student hours, evaluations, and reflections—students can count up to 250 verified hours toward Ohio's graduation competency requirement.



Real World Experience

Students participate in paid or unpaid positions, internships, or school-based enterprises that connect classroom instruction with real job skills.



Accel Team Support

The Accel CTE team provides guidance, resources, and templates to help schools design, document, and manage work-based learning experiences in compliance with Ohio CBI standards.

Middle School WBI

No paid employment or off-site placement is permitted for 7th and 8th grade students. Middle school students can participate in WBL-related activities, but only at the career awareness or career exploration level. Activities may include guest speakers, career fairs, simulations, classroom projects, or short-term job shadowing.



Implementation

1 Initial Consultation

During the initial consultation, the Accel CTE team meets with school leaders to review program goals, outline CBI requirements, and create a clear roadmap for successful implementation and compliance.

3 Training and Mentorship

The Accel CTE team provides ongoing training and mentorship to help new CBI coordinators build confidence, understand compliance requirements, and deliver high-quality career-based learning experiences.

Course Registration

During course registration, schools work with their Accel and EMIS teams to ensure the CBI anchor course (252525) and any related classes are correctly coded and scheduled in accordance with Ohio CTE reporting requirements.

2 Application Process

The Accel CTE team manages the entire CBI program application process, ensuring all required documentation, approvals, and supporting the EMIS setup steps are completed for state submission.

4 Curriculum Selection

Curriculum selection is completed at the school level, allowing districts to choose CBI-aligned materials that best meet their students' needs while ensuring alignment with Ohio CTE standards and program requirements.

6 Ongoing Support

The Accel CTE team provides ongoing support through regular check-ins, compliance reviews, and technical assistance to help schools maintain program quality and meet all state requirements year-round.

Application Information

The Accel CTE team oversees the full CBI program application process, ensuring all required forms, documentation, and approvals are accurately prepared and submitted to the school's CTPD for state review. Applications are typically due in December prior to the school year of implementation, allowing time for staffing, course setup, and EMIS alignment before classes begin.
